## **CONSENT TO THE PROCESSING OF PERSONAL DATA**

Pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data (hereinafter as the "**Regulation**") and pursuant to Act no. 101/2000 Coll., on the protection of personal data (hereinafter as the "**Act on the protection of personal data**"), I hereby give consent to the company Thermona, spol. s r.o., with registered office at Stará osada 258, 664 84 Zastávka u Brna, registered in the Commercial Register administered by the Regional Court in Brno, file no. C, insert 413, Company Reg. No.: 13692861, (hereinafter as the "**Controller**") to collect, process and store my personal data. I am aware of the fact that Personal Data are processed automatically as well as manually, directly by the Controller's employees and Processors authorized by the Controller, and especially by service and assembly partners bound by a contract.

The Controller has informed and instructed me that pursuant to the Regulation I can exercise the *right of deletion from the database, the right to access my personal data, the right to restrict the processing of my personal data, the right to know what personal data are processed* and the right to turn to the "Data Protection Authority" in case of any doubt about compliance with the obligations concerning the processing of Personal Data. Intent to exercise the aforementioned rights, as well as withdrawal of this consent, shall be delivered to the Controller in writing to the address of the registered office, or by e-mail to privacy@thermona.cz.
